# **CPI LAUNCH EVENT UNITES AGENCIES**

As our first official major interventions of the year we officially launched the 2020 Corruption Perceptions Index (CPI) in late January at the Lamana Hotel in Port Moresby.

A focus for this year's CPI report was to measure, in the various countries, the impact of persistent corruption on health care systems and the how this may contribute to the erosion of democratic norms.

The CPI results showed the impacts were more pronounced amid the recent COVID-19 pandemic for countries with low scoring.

In launching this year's CPI report TIPNG highlighted that PNG scored 27 out of 100 on this year's index, with a ranking of 142 out of 180 countries assessed

The 2020 CPI results were officially launched in PNG under the theme: "Putting the sight back in oversight".

Following our assessment of recent legislative changes introduced by our PNG government, TIPNG is recommending four core areas which we believe if focused on will have the potential to drastically reduce the impact of corruption in country. TIPNG's four recommended areas of focus are:

#### • STRENGTHENING OVERSIGHT INSTITUTIONS:

Anti-corruption authorities and oversight agencies must be independent of political influence and must have appropriate funding to perform their duties effectively.

#### • ENSURING OPEN & TRANSPARENT CONTRACTING:

Improved transparency in government tendering and expenditure will ensure that resources reach those most in need.

#### • PROMOTING GREATER CIVIC SPACE:

Allow for active citizen engagement, better use of public consultation forums in planning and National Budget development so that government can be more accountable to citizens.

#### • IMPROVE ACCESS TO PUBLIC INFORMATION:

Ensuring the public is able to better access public information in a timely manner will assist achieve greater transparency and accountability for Government.

This quarter has also seen the achievement of a number of milestones. Such as the completion of data collection for our National Integrity Systems Assessment, completion of the 4th Legal Internship Program and participation in the NCD Provoncial Electoral Steering Committee (PESC).

While adapting to our new operating conditions has been a challenge, the outpouring of public support towards our cause has been extremely encouraging and we have now exceeded half our membership target for 2021!

Moving forward, we look forward to even greater collaboration and partnership next quarter and even better outcomes for our people.

# **DIALOGUE UNITES**

In support for government efforts to introduce effective anti-corruption reforms in PNG, we facilitated an Anti -Corruption Enforcement Dialogue with the leaders of over 13 law and justice sector agencies, in tandem with the official launching of the 2020 Corruption Perceptions Index (CPI) on Thursday January 28, 2021.

TIPNG Chair, Peter Aitsi stated that the aim of the dialogue was to unify the different voices within the PNG Law and Justice Sector and present a consolidated position on their challenges, priorities and proposed solutions to the government. "While PNG has made significant strides towards the achievement of a number of key milestones in the past few years, there is still more work to be done towards achieving tangible anticorruption reform before any real impacts can be felt at the community level," said Mr Aitsi.

"Key legislative reforms such as the Organic Law on the Independent Commission Against Corruption (OLICAC), the Protected Disclosures Act (PDA) and the Freedom of Information (FOI) Law have been touted for some time now. And while the OLICAC and the PDA have now been passed on the floor of Parliament, and the FOI legislation is currently in its drafting phase; the need for greater consensus and solidarity from Law and Justice Sector agencies still presents itself as a hurdle to the effective implementation of anti-corruption enforcement pathways (such as the ICAC)."

"This event was delivered through a dialogue format, with the intention of opening the dialogue among participating agencies to exchange ideas and ultimately developing a resolution on anti-corruption priorities for the Law and Justice Sector. Which will be presented to the PNG government," He said.

As a core output of this event, a discussion paper is now being developed from the dialogue and will be presented to the government, to inform the current policy agenda on anti-corruption reform.

# **TIPNG TALKS ICAC ON LOWY PANEL**

In February TIPNG participated in a panel discussion convened by the Lowy institute. The Panel highlighted significant issues for PNG in the year ahead. The discussion was moderated by Shane McLeod from the Lowy Institute and the panelists included; Yuambari Haihuie (Deputy Director Policy and Partnerships, TIPNG), Patrick Kaiku (UPNG) and Rebecca Kuku (Post Courier).

One of the interesting topics to come up in the discussion was the portending impact of recent developments such as the ongoing delay to the establishment of a fully empowered ICAC and how these factors would play out in the lead up to the PNG National Elections next year.

At the official launch event, TIPNG Board Chair Peter Aitsi stated that corruption was not an issue, which could solely be addressed by the government, but that greater collaboration and solidarity is critical to ensure effective and sustainable change is achieved.

"Greater collaboration is needed from all state and nonstate actors to ensure that the recent reforms by the government are effectively implemented and translate into meaningful change at the community level.

The impact of corruption in our country cannot be reduced unless we demonstrate solidarity and each person plays their part in driving the change we want to see in our country," said Mr Aitsi.

During their time with us the legal interns were involved in attending stakeholder meetings, providing legislative and briefing papers to the board, providing recommendations on issues of national concern as well as collecting, filing and processing complaints under the Anti-Corruption Help Desk (AnCoHD).

The closing ceremony signified yet again the success of the program and the contributions of the legal interns towards pursuing our mission.

The staff of TIPNG, friends, parents of the legal interns and partners who contributed to the program were present at the ceremony to witness the awarding of certificates, addresses from the AnCoHD Coordinator, the CEO and the legal interns themselves who shared their individual experiences and takeaways.

The four LIP graduates expressed that they were grateful for the experience and the exposure which they recieved over the course of the 8-week internship.

And that while the LIP program provided them the environment and the opportunity to apply what they had learnt in Law School, the experience was also further supplemented with critical insights into key agencies in the PNG governance framework as well as the importance of civil society and civic participation in a functioning democracy.

### **UNCAC PARALLEL REPORT UNDERWAY**

Data collection for the United Nations Convention Against Corruption (UNCAC) Parallel Report for PNG began in December of 2020. PNG signed the UNCAC on the 22nd of December 2004 and acceded to it on the 16th of July 2007.

Under the UNCAC, member states are to provide a report on the implementation and fulfilment of obligations on a multi-year periodic basis. As a civil society organization, TIPNG was engaged by the UNCAC Coalition to provide a parallel report to that of the government's, for the purpose of ensuring accountability, transparency, and credibility of the review process.

Towards the end of February 2021 interviews were conducted with key agencies such as the National

Procurement Commission and the Public Services Commission, to obtain information crucial to the report. The report will provide an independent assessment of the country's overall progress by highlighting level of implementation and enforcement of the country's obligations under the UNCAC.

Following the ratification of the UNCAC, PNG developed a National Anti-Corruption Strategy 2010-2030 which has five-year Plans of Action, the current was endorsed by NEC last year is from 2020-25.

The National Anti-Corruption Strategy Taskforce, cochaired by the Department of Justice and Department of Prime Minister, is responsible for UNCAC implementation in PNG.

## **BUILDING PARTNERSHIPS WITH INFO**

In February the Oxfam Governance Team and the Goroka District Education Office team visited our office to learn more about the Civic Education Materials developed by TIPNG.

An MoU is existing between TIPNG and the Department of Education, for the production of the Civic Education materials, yet to be approved. The materials include student and teacher resource books, a book of posters and 'big books' for elementary students.

Through information sharing with organisations like Oxfam, we are able to reach more Papua New Guineans across the country.

### **NISA DATA COLLECTION COMPLETED**

We are pleased to announce that the data collection for the National Integrity Systems Assessment (NISA) is now complete!

The data collection started in November 24th 2020 and ended in February 12th 2021.

Over these 3 months, 27 interviews were conducted by an external consultant with selected agencies and organizations.

The purpose of the data collection period was to obtain information relating to governance, integrity and anticorruption within agencies.

It is our intention to maintain relationships and partnerships formed with these agencies, as we work towards improving levels of national integrity in PNG.

In addition to the data collection, experts with extensive knowledge and experience within the pillars of National Integrity were also interviewed.

The information obtained during this period will be used in the NISA Report, which will be launched at the first National Integrity Summit in May of 2021.

The NCD Provincial Election Steering Committee (PESC) Meetings have kicked off. The first meeting was held on Thursday the 28th of January 2021 at the NCD City Hall. Since the first meeting, 4 others have been held.

The PESC is a means to coordinate the conduct of elections in a province and, was convened for the Moresby North-West By-election following the passing of late Sir Mekere Morauta.

The committee brings together Election officials, Provincial Administration, Police, Education authority, Faith Based Organisations and broader Civil Society. TIPNG has been a member of the NCD PESC since its inception.With the 2022 National Elections fast approaching, the PESC will be further tasked with ensuring its coordination.


While we are also collecting complaints through other mediums such as; Email, Postage and though our Toll-Free line (**180 6000**).
