GALVANIZING REGIONAL SUPPORT FOR THE CCAC

The Second quarter took off on an exciting start for us at TIPNG as we worked through the Community Coalition Against Corruption (CCAC) to galvanize regional support in response to the concerns expressed by communities on the overall poor governance environment and the difficulties caused by corruption in PNG.

The CCAC in collaboration with the Lae Chamber of Commerce held its first national meeting in Lae International Hotel, which saw the participation of 46 community-based organizations and industry representatives, including the Trade Union Congress, the media, and 18 members of the Lae Chamber of Commerce & Industry representing the business sector. Participants came from all regions of Papua New Guinea. The Meeting was funded by the European Union in PNG through the UNDP Anti-Corruption Project.

At the meeting, participants identified issues of national impact that the CCAC should take on as priorities to focus on s campaigns. The next step being to articulate the issues into a consolidated priority list and develop a work-plan that will be shared with the coalition. The

CCAC is now working to set up a steering committee that will ensure continuity of the campaigns on these issues nationally.

The CCAC is a loose network of organizations and community networks that come together to discuss and make recommendations on national governance issues. TIPNG and the Media Council of PNG currently co-chair the CCAC. The Coalition's operations, its agenda and priorities are determined by CCAC members. The CCAC works through its membership to empower communities to be informed, mobilize and take action on corruption.

The second quarter was an extremely busy period for us at TIPNG. At the top of the quarter, we hosted the inaugural National CCAC meeting in Lae in collaboration with the Lae Chamber of Commerce & Industry. Participants came from all four regions and showed support to the work of the CCAC.

We continue to Co-Chair the PNG Open Government Partnership (OGP) initiative and we encourage other CSOs to engage in the OGP National Action Plan 2 (2022 – 2024).

We held our 2022 Annual General Meeting in June and saw the appointment of the new Board. We achieved another unqualified audit report that you can read in our 2022 Annual Report.

Our Promoting Anti-Corruption & Integrity Strategies (PAIS) Project reached its end phase and we are grateful for the funding support by the European Union. The PAIS project was a 3-year project that allowed us to assess the integrity systems of state agencies and working with the agencies to develop anti-corruption strategies to be more effective in their mandates.

At TIPNG, we are committed to seeing better elections and as such we continue to engage with actors of our election administration to ensure that the recommendations from our election observation report are taken up. And we acknowledge the Special Parliamentary Committee on the 2022 National General Elections for the work they have done so far through the public hearings and the regional consultations.

NJSS LAUNCHES ANTI-CORRUPTION STRATEGY

At TIPNG, we are committed to working with a sense of urgency and purpose to ensure that Papua New Guineans are bold enough to stand up against all forms of corruption. We want to critically but constructively engage with all stakeholders and encourage popular demand for good governance and accountability.

The partnership between TIPNG and the National Judicial Staff Services (NJSS) first commenced in October 2021, and the launch of the NJSS's Anti-Corruption and Integrity Strategy 2022-2025 is a milestone achievement towards the government's efforts in achieving the National Anti-Corruption Plan of Action 2010 – 2030.

The NJSS's commitment in developing its anticorruption strategy speaks to the importance the agency places on ensuring that it is fully equipped to fulfill its mandated functions.

This initiative was made possible by TIPNG through our Promoting Anti-Corruption & Integrity Strategies (PAIS) Project. The overall objective of this project is to strengthen public trust in our state agencies. This can only be achieved in collaboration with Government, Civil Society, Media and the Private Sector. The fight against corruption is one that cannot be won alone.

The development of the Strategy was possible through funding support from the European Union, through the PAIS Project. Technical support for the development of the strategy was provided by Square Circle, a Brisbanebased firm focused on International Development.

AGM APPOINTS NEXT GENERATION OF LEADERSHIP




We held our Annual General Meeting at the end of June and presented our annual report for the year 2022 to our members. The 2022 Financial Statements for TIPNG where presented to the members present and once again, TIPNG returned an unqualified audit which was conducted by DFK Mayberry and represented fairly the Association's financial position and of its financial performance in accordance with accepted accounting practices in Papua New Guinea and the Associations Incorporation Act 1966.

The financial members of TIPNG at the AGM elected Peter Aitsi as chair, Belinda Kanau as secretary to serve for the coming year. Other directors re-appointed were Richard Kassman, Christopher Elphick, Michael McWalter, Bill Doa Neill, James Lunge, Stephanie Kirriwom-Sawong, Paul Barker, Mary Udu. The two new directors to the Board of TIPNG were Jeffery Vagalia and William Koregai.

At TIPNG, the role of director is voluntary and the directors receive no payment for their leadership & service to the organization. The Board is responsible for setting of the organization's strategy, vision, reinforcing its purpose and over-sighting its financial performance. As well as ensuring statutory compliance and with management guiding the overall performance of TIPNG.

In the coming months, the Board will focus on implementing the objectives contained in its Strategic Plan 2019-2023 which is now in its final year. The strategic priorities remain strengthening its brand, continuing the building of stronger and more active partnerships, ensuring financial sustainability and strengthening organizational capabilities.

TIPNG will continue to advance a number of key priorities including generating awareness of the PNG Independent Commission Against Corruption, closely working with stakeholders to drive the reforms to secure and improve the conduct of our national general elections, and importantly building and supporting the role of the Community Coalition Against Corruption as a united voice on major national issues. We remain committed to our primary role and that is to empower people in PNG to act against corruption.

THE OPEN GOVERNMENT **PARTNERSHIP**



What is the Open Government Partnership (OGP)?

The Open Government Partnership is a multi-stakeholder forum that provides an international platform for dialogue. This initiative brings together government reformers and civil society leaders in over 70 countries to create action plans that make governments more inclusive, responsive and accountable. In the spirit of multistakeholder collaboration, OGP is overseen by a Steering Committee including representatives of governments and civil society organizations.

The PNG OGP

PNG showed interest to join the Open Government Partnership global initiative in 2014 at an Asia-Pacific Regional Conference in Bali, Indonesia. The intention was endorsed by the PNG Government in September of 2015. Since then, the 1st National Action Plan for PNG OGP was developed and implemented in 2018 to 2020.

Why should OGP matter to you?

- 1. A way to hold government to account
- 2. A chance to stand out The government have an obligation to give citizens the opportunity to play a part in decision making and have more control over the entire process, from defining problems in their communities through to implementing solutions.
- 3. An opportunity to lead the way We should use the open government platform to champion further innovation in our democratic processes and institutions, looking to our global partners for solutions to build more genuine engagement.
- 4. A way to build trust between citizens and the **Government**

What is TIPNG's role in the PNG OGP initiative?

The PNG OGP is co-chaired by the Department of National Planning and Monitoring and TIPNG.

As part of our role as co-chair of the OGP, we facilitate meetings with the wider civil society organizations to monitor the Government's implementation of the agreed National Action Plan. This ensures that the government is more open and accessible to the people to ensure quality service delivery.

TIPNG works predominately on the Access to Information cluster group with the Department of Communication and Information. We are pushing for the introduction of a Freedom to Information law for PNG.NAP.

The National Action Plan 2 (2022 - 2024)

The second OGP National Action Plan for Papua New Guina is from 2022 to 2024. The Plan captures six clusters and 16 commitments for PNG to deliver.



MEDIA FREEDOM DAY AT DWU

With one of our recent recommendation for the Draft National Media Development Policy 2023 is for the "government to focus on up-skilling journalism students and media professionals, and protection of journalists from political and corporate censorship." we accepted an invitation by Divine Word University (DWU) to attend the Media Freedom Day (MFD) in Madang.

Our Deputy Director for Communications Ms. Yvonne Ngutlick was part of the distinguished panel with the UN Resident Coordinator H.E Richard Stephen Howard and prominent journalist Mr. Scott Waide.

During the panel discussion, Ms. Ngutlick emphasized the media's role as the Fourth Estate and reiterated the steps leading to TIPNG's review of the Draft National Media Development Policy 2023 which hoisted TIPNG's highlevel recommendations to the PNG government to ensure that processes are being followed and citizens are given time for consultations to take its course. The media's role in PNG must be a tool for accountability as portrayed in democratic countries. Freedom of Expression or media freedom will permit institutions like TIPNG to hold people in power accountable.



TIPNG PARTICIPATES IN FISHERIES TRANSPARENCY **INITIATIVE WEBINAR**

The Fisheries Transparency Initiative (FiTI) is a global voluntary partnership initiative that seeks to increase transparency and participation for a more sustainable management of marine fisheries. FiTI represents a diversity of different stakeholders in a central feature for implementation, good governance and equal participation.

In this quarter, TIPNG Deputy Director Partnerships & Policy Mr. Yuambari Haihuie participated in an online discussion about the challenges of Fisheries Transparency in Small Islands Developing States (SIDS) which includes relatively weak systems for open government including online platforms for government data shared with the people. Mr. Haihuie highlighted TIPNG's role as the civil society co-chair of the PNG OGP. The platform is an avenue for civil society organizations to engage and ensure accountability of Papua New Guinea's resources, including our marine resources, and the agencies that work within the sector.

WORK ON SOCIAL ACCOUNTABILITY SHARED AT CPP FORUM

The Building Community Engagement in PNG (BCEP) Program and the Church Partnership Program (CPP) recently hosted a partner forum. The forum created an avenue for partners to create dialogue for lessons learnt in 2023.

TIPNG's Coalitions Engagement Lead Ms. Barbra Ruin shared TIPNG's work on social accountability and emphasized the fundamentals of good governance.

Ms. Ruin outlined the TIPNG-led campaigns and advocacy work on the COVID 19 Accountability and the Accountability Scorecard. She added that the result of TIPNG's work can be measured based on;

- 1. The number of people that have taken action against corruption.
- 2. The number of agencies that implemented anticorruption policies in their organization.
- 3. The number of reforms that are passed in Parliament to ensure transparency and accountability.
- 4. Or the number of people that have reported cases of corruption to the responsible authorities.

Ms. Ruin shared a panel with representatives from CARE International, Department of National Planning & Monitoring, PNG Council of Churches and Tearfund.

ENGAGING WITH PASAI ON WEBINAR

PASAI is an official association of the Supreme Audit

Institutions (SAIs) in the Pacific. It is one of the seven regional organizations belonging to the International Organization of Supreme Audit Institutions. PASAI promotes transparency, accountability, effective and efficient use of the public sector resources in the Pacific.

Ms. Kassman highlighted TIPNG's engagement with multi-stakeholder forums in the areas of shared interest with the PNG Auditor General's Office to ensure that upto-date audit reports are made publicly available.



TI ASIA PACIFIC REGION CHAPTERS MEET IN BANGKOK



In June, TI hosted its national chapters of the Asia-Pacific region during a programme meeting in Bangkok, Thailand.

The meeting was part of the Indo Pacific Partnership for Strong, Transparent, Open Networks and Good Governance (IPP STRONGG) Programme. The meeting allowed chapters to take stock of our impact achieved, reflect on lessons learnt and to develop the next phase of the programme.

TIPNG was represented by the Board Secretary, Ms. Belinda Kanau, who shared our 23-years campaign for the establishment of an Independent Commission Against Corruption (ICAC) and other work that we have done in pushing for greater accountability of public funds.

The IPP STRONGG Programme is a multilateral funding arrangement by the Australia Department of Foreign Affairs and Trade (DFAT) and New Zealand's Ministry of Foreign Affairs and Trade (MFAT) through the TI Secretariat.

TIPNG's IPP STRONGG Programme runs our coalition work through CCAC, stakeholder engagements, Anti-Corruption Help Desk and other core operations.

PNGEITI FINANCIAL REPORT LAUNCHED

As President for the Papua New Guinea Resource Governance Coalition (PNGRGC), we spoke at the press conference organized by the PNG Extractive Industries Transparency Initiative (PNG EITI) for its Financial Report Launch.

At the press conference, TIPNG CEO Ms. Arianne Kassman addressed the status of PNGRGC and reiterated the representation of civil society within PNG EITI. Ms. Kassman continued to speak on the value of the work being done through PNGEITI and welcomed the publication of the two reports covering the fiscal years 2020 and 2021.

Ms. Kassman added that the civil society is ready to be engaged with partners in the PNGEITI to achieve the shared vision for PNG, where good governance ensures the value of the resources for the benefit of the people.

ADVANCING PNG'S ANTI-CORRUPTION AGENDA: UNCAC COALITION

Our Deputy Director Partnerships & Policy, Mr Yuambari Haihuie, was invited as a panel speaker at an online session organized by the United Nations Coalition Against Corruption (UNCAC) Coalition sponsored by the United Kingdom.

The panel Event was organized on the side lines of 14th session of the UNCAC Implementation Review Group (IRG) and the discussions were aimed at impacting the remaining country reviews TIPNG had the opportunity this year to work with counterparts in the Government to ensure that the country fulfilled its international commitment to address corruption.

Mr Haihuie shared TIPNG's experience of our involvement in the country's second cycle review and discussed TIPNG's expectations regarding the follow-up to the country review; how PNG should address the review recommendations and how PNG Government should keep engaging with civil society and inform about their follow-up actions.


Background

Papua New Guinea signed the United Nations Convention against Corruption (UNCAC) on the 22nd of December 2004 and ratified it on the 14th of June 2007. The UNCAC is the leading global instrument guiding implementing states on areas in which to prevent and prosecute corruption, it is not compulsory and it doesn't measure corruption in implanting states. The UN Office of Drugs and Crime (UNODC) provides secretariat support for UNCAC.

The UNCAC implementation review process comprises two five-year cycles. The first cycle (2010-2015) focuses on criminalization & law enforcement, and international cooperation The second cycle (initially 2015–2020) focuses on preventive measures and asset recovery.

As part of the review process an implementing state, firstly does a self-assessment, secondly it is then peerreviewed by two other implementing countries through desktop review and interviews, and lastly with the help of the UNODC a country review report and executive summary are produced.

Papua New Guinea began its UNCAC 2nd Cycle of Review in 2021. The process of review was coordinated by the Department of Justice and Attorney General and the Department of Prime Minister and NEC in their capacity as co-chairs of the National Anti-Corruption Strategy Task-force (NACSTF). The NACSTF is the coordinating body for implementation of UNCAC in PNG.



IDEC SUMMIT MAPS ELECTORAL REFORM FOR PNG

The Inter-Departmental Elections Committee (IDEC) convened a three-day summit in April with key stakeholders to discuss lessons learned from the 2022 National Election and to consider options for future electoral reform. The National Research Institute and the Australian National University jointly facilitated the three-day event.

TIPNG was invited to participate in the summit where day one consisted of high-level presentations from a range of speakers and the second and third days consisted of smaller working groups to map recommendations for reform, drawing on the lessons from the first day.

TIPNG remains firm in its call that Strategies to improve the conduct of National Elections in Papua New Guinea should include focus on promoting transparency and integrity throughout the entirety of the 5-year electoral cycle and any reforms undertaken must be free from political self-interest.

PACIFIC YOUTH CONFERENCE ON GOVERNANCE

TIPNG's Civic Engagement Lead Ms. Elizabeth Aribi and Legal Intern 2022-2023 Ms. Courtneyalla Dotson travelled to Auckland, New Zealand to attend the Pacific Conference on Governance based on the theme "Pacific Youth Spotlighting Anti-Corruption in Climate Change and Gender Equality". Our team's mission was fully funded by United Nations Development Program (UNDP) in PNG.

The mission placed TIPNG's representatives amongst 18 youth representatives from around the Pacific to attend the two-day conference that enabled a platform to raise awareness, facilitate knowledge exchange, promoting women's leadership and youth empowerment to strengthen the Pacific Youth Unity against corruption.

The conference was supported by UNDP under the Strengthening Anti-Corruption, Transparency, and Accountability in the Pacific Islands Countries (Pacific Anti-Corruption Project) funded by the UK Government and the UN Pacific Regional Anti-Corruption Project funded by the Government of New Zealand.

NZ HIGH COMMISSIONER PAYS A VISIT

The New Zealand High Commissioner to Papua New Guinea His Excellency Peter Zwart visited the TIPNG office as part of his introduction.

H.E Peter Zwart was welcomed by TIPNG CEO Ms. Arianne

Kassman and the staff of TIPNG. The Ambassador and the CEO discussed the current work of TIPNG on elections and youth empowerment amongst others. TIPNG receives multilateral support from New Zealand through the IPP STRONGG Program.
